---- RENTAL POLICY AND REGULATIONS ----

Payment is due on Event Date by cash, credit card, or cheque (made out to Calgary Lawn Bowling Club).

A \$250 cancellation fee will be charged if the Group does not provide 24 hour notification of its intention to cancel the event. There is no payment or cancellation fee required in the event The Club notifies the Contact of unplayable conditions due to weather or other unforeseen event outside its control.

The Group acknowledges they are solely responsible for their guests and their behavior and further agree that the Group is collectively responsible for all liabilities, expenses, damages or loss to The Club facilities, equipment, BBQ, or other items on premises during the period of the rental. The Group agrees to possess sufficient Corporate Liability Insurance or has purchased Event Insurance.

Alcohol is permitted to be consumed within the black chain link fenced area if the Group possesses and prominently post the appropriate permit pursuant to AGLC regulations. The Group will have provisions for designated drivers or alternative transportation arrangements for their participants and agrees to not serve alcohol to minors. The Group is solely responsible for any liability of the attendees during or following the event due to the consumption of alcohol or other items consumed. Tobacco smoking is permitted at designated areas outside the fenced area.

A BBQ is available for rental. Equipment (such as flippers), fuel and subsequent grill cleaning will be provided by The Club. Music may be played on an outdoor speaker providing The Group acknowledges and agrees to abide by City of Calgary noise bylaws and to be respectful of the facility neighbours. Club shirts are available for purchase.

The Group is responsible for leaving the venue in the same condition as it was on arrival. This includes the removal of refuse or placement in the bins provided on premises. **Failure to do so will result in a \$50 clean-up service fee.**

All guests agree to wear flat soled shoes (no heels or deep treads) or to play barefoot to protect the greens.

The Group agrees that they are responsible for the supervision and care of all individuals who may be dependent on others due to disability, age, or other circumstances.
